

Bellerbys College consistently produces international students who are capable of winning places at the UK's very best universities and this year is no different. Our students have once more won prestigious places at the best academic institutions. Many have achieved three or four A-grade A Levels: remarkable achievements. These exceptional results are a direct reflection on the outstanding teaching, pastoral care and facilities we offer – coupled with the hard work and dedication of the students themselves. A Levels

A Level results in 2005 were typically excellent. 65% of our A Level students progressed onto undergraduate degree studies at the UK's top 20 ranked universities.

- ▶ 75% of all students' grades were A or B
- ▶ 33% of all students achieved AAA or better
- ▶ 6 students gained places at Cambridge University
- ▶ 17 students gained places at The London School of Economics
- ▶ 16 students gained places at Imperial College, London



2005 Results

Exceptional success

at the UK's top college for international students

In 2005, Bellerbys students achieved their best results ever. One third of all Bellerbys students – across all four centres – achieved three A grade A Levels or better. Hundreds of Bellerbys students have now gone on to attend the UK's top universities, including Oxford, Cambridge and the London School of Economics.

Foundation

- ▶ Over 400 students gained university degree places
- ▶ 25% of all students went on to study at the UK's top 20 universities
- ▶ 15% of all Foundation students achieved distinctions (75% and above)

Pre-Masters, Masters Qualifying Programme and Business Degree

- ▶ 100% of Pre-Masters & MQP students were placed on university Masters programmes – many at top universities
- ▶ Another year of happy Business Degree students; all graduating in a shorter time than they would have done at university
